

**THE FOLLOWING QUESTIONS APPLY TO APPLICATIONS FOR
PRIVATE SCHOOLS, CHILD CARE, NURSERY
OR PRESCHOOL FACILITY**

1. Describe the type of school (e.g., elementary, junior high school, nursery, etc.)

 Currently: Large Family Child Care up to 14 children
 After CUP: Child Care Center up to 32 children

2. What is the maximum number of students (children) to be enrolled at each grade and age level?

 Currently: Total 14, no more than 3 infants and 12 if 4 infants. One child is in Kindergarten and one is school age.
 After CUP: 32 ages infant to school age, subject to State restrictions regarding age distribution.

3. What are the hours of operation? Indicate whether Monday through Friday only or also weekends.

 6:30 – 6:00 PM, Monday-Friday (No weekends)

4. What are the number of classrooms and teachers?

 Currently: Two classrooms, one playroom, one kitchen, two restrooms, and 4 teachers/teachers assistants including the owners.
 After CUP: Three classrooms, one kitchen and break area for staff, three restrooms, one office. 6 teachers plus director and owner.

5. What are the number of administrative staff?

 Currently: 1 (owner/licensee)
 After CUP: Two: (Director and Substitute or Assistance Director)

6. Will there be busses, and, if so, where will they be stored?

 Currently: Not at present.
 After CUP: We are not proposing them at this time, should the need arise will have to address then

7. Where will cars load and unload students? How many cars?

 Currently: Curbside, carport
 After CUP: Curbside, Carport (Carport will be designated for staff parking or used for visitors). The applicant has applied to LADOT for a green curb for exclusive use by the facility during peak dropoff/pickup times.

8. Describe the size and location of signs.

Currently: One 1 ft x 8 ft carport text-only sign and 3 ft x 4 ft graphic front yard sign.
After CUP: One 1ft x 10 ft sign or one 2 ft x 5 ft sign.

9. Does anyone live on the premises; if so, where?

Currently: Yes: the applicants and their 7 years old twins (total: 4 residents). Only Ms. Alali is present in the child care area during child care hours together with staff and children in care.
After CUP: No.

10. Are there to be special events, e.g., fund-raising events, parent-teacher nights, graduation ceremonies, or athletic events? How often are these proposed?

Halloweens, Christmas, Graduation, Parents meet and greet one time annually. Events will be held off-site when the number of attendees is more than 12 families.
